Minutes of South Beaver Township Regular Meeting

April 9, 2018

The regular April meeting of the South Beaver Township Board of Supervisors held in the South Beaver Fire Hall located on State Route 168 was called to order at 7:00 P.M. by Chairman Robert Wood. The Pledge of Allegiance followed.

Robert Wood made a motion to approve the minutes of the regular March meeting. Jack Mintier seconded the motion. Motion carried.

Robert Wood made a motion to approve the Treasurer's Report and pay the following bills: General Fund, Check No. #13170-#13220, Total \$53,089.06; Payroll Fund, Check #9679-#9701, Total \$20,822.46; PLGIT Bond, Check #129-#131, Total \$52,278.44. Jack Mintier seconded the motion. Motion carried.

Robert Wood made an announcement that on March 28th at 11am the Supervisors and Ashley Carr met with WesBanco to sign paperwork for the new road department truck and on March 28th at 6pm the Supervisors and George Patterson held an executive session on a personnel matter.

Kevin Brett gave the engineers report. It will be filed.

Dan McLean read the police report. It will be filed. Dan reported that the ballistics door panel for the explorer has been ordered and will be ready in 6-8 weeks. The department received a resignation from Jim McGeehan and Dan asked if it would be ok to hire someone to replace him. The supervisors agreed in finding a new part time patrolman.

A copy of the road report was distributed. It will be filed.

There was no fire report.

Larry McCandless reported that with the bridge being closed on 168 there needs to be better signage so vehicles have a chance to turn around before they get to the closed bridge. Dan McLean said he had called them earlier in the day after receiving a few phone calls on the placement of the signs at intersections, especially the one at Blackhawk and Georgetown. Dan said that he would call them again in the morning.

Larry informed the Supervisors that the fire departments ISO rating is coming up in June and asked what the Supervisors planned on doing for Engine 611. The Supervisors agreed the repairs would be too costly for the age of the truck and asked Ashley Carr to contact COSTARS to see if they have fire truck contracts and Larry will look at Spartan. Kevin Brett reported that he hears municipalities he works with talk a lot about leasing fire trucks and will report back to Ashley Carr on his findings.

Tom Miller made a motion to approve the Partial Payment No. 3 to TEC Electric for \$20,812.50. Robert Wood seconded the motion. Motion carried.

Robert Wood made a motion to approve Partial Payment No. 8 to CW Smith Contracting for \$62,010.40. Jack Mintier seconded the motion. Motion carried.
