## Minutes of South Beaver Township Regular Meeting

**December 9, 2019** 

The regular December meeting of the South Beaver Township Board of Supervisors held in the South Beaver Municipal Building located at 805 Blackhawk Road was called to order at 7:00 P.M. by Chairman Robert Wood. The Pledge of Allegiance followed.

Officials present: Robert Wood, Thomas Miller, Jack Mintier, John Heyl, George Patterson, Dan McLean, Ashley Carr.

Robert Wood made a motion to approve the minutes of the November 25<sup>th</sup> meeting. Jack Mintier seconded the motion. Motion carried.

Robert Wood made a motion to approve the Treasurer's Report and pay the following bills: General Fund, Check No. #14087-#14122, Total \$30,622.50; Payroll Fund, Check #10331-#10356, Total \$24,841.64. Jack Mintier seconded the motion. Motion carried.

John Heyl gave the engineers report. It will be filed.

Dan McLean read the police report. It will be filed. Dan reported that on Darlington Road near the intersection of Louthan Road there have been 10 accidents this year when in 2014 and 2016 there was only one. He said that since the road had been redone last year it is very slick and the accidents are happening when the road is wet. He asked the supervisors if the Township could write a letter to Penndot asking them to look into the issue. George Patterson asked for Dan to get the information to Ashley Carr and he will write the letter.

A copy of the road report was distributed. It will be filed.

Ashley Carr gave the fire report. It will be filed.

It was brought to the Supervisors attention that there was damage to the fender on the new fire engine. Robert Wood would like for the fire department to be responsible for the negligence. Tom Miller stated that the Chief signs off when he feels that a person is able to drive but he feels like they should be taking emergency vehicle training courses. Robert Wood would like for the fire department to keep better bookkeeping and driving logs.

Adam Kahle of troop 766 was present and requested that an eagle project be done in front of the Township building, such as a bench to honor veterans. Adam stated that this would occur in spring or early summer depending on donations and help. Dan McLean suggested that once Adam knows what he would like to do that he submit a proposal drawing to the Township. All of the supervisors were in favor of the eagle project and thought that it would be a nice addition to the Township building.

Robert Wood made a motion to approve the service order authorization from LSSE to update the Subdivision and Land Development Ordinances for \$19,500. Tom Miller seconded the motion. Motion carried.

Robert Wood made a motion to approve the purchase of a 2020 Ford Police Responder F150 with add ons to change over car and for the purchase of CrimeStar Software from Act 13 funds. Jack Mintier seconded the motion. Motion carried.

Robert Wood made a motion to sign the Return of Uncollected Real Estate Taxes for Tax Collector Robin Huston. Jack Mintier seconded. Motion carried.

Robert Wood made a motion to award the contract for Swamp Poodle Road Bridge Deck Replacement to JET Excavating Company for \$117,510.00. Jack Mintier seconded the motion. Motion carried.

Ashley Carr reported that the Township is in need of an auditor for the 6 year term. She asked the Supervisors to ask around or let her know if they had anyone in mind, she will contact the past auditor Denise Daquila and see if she is interested in another term.

Robert Wood adjourned the meeting at 7:20 P.M.
